2018 Budget, Final Approval (R3)	The budget was circulated for board member review with highlighted sections including the increase for ED salary from 24 to 32 hours/weekly and the lack of continuing education expense. B. Bockenhauer suggested that supportive help (staff) might be helpful to the ED on a per diem basis. In preparation for this discussion, J. Widmer drafted a one year retrospective time log showing an average of 40.2-43.5 hours per week. J. Widmer opined that the ED has adequate support from the commission chairs, board of directors and NEMSD with the exception of certain annual events.
